Statement of Qualifications (SOQ) Scoring Matrix

Step 1: Assessing a Respondent's Qualifications Package

A Respondent's Qualifications Package will be assessed for responsiveness as described in Section 5 of the RFQ.

Step 2: Assessing Minimum Qualifications

A Respondent's Qualifications Package will be assessed based on answers to PART IV: MINIMUM REQUIREMENTS FOR QUALIFICATION in the required Statement of Qualifications (Appendix A). Scoring of PART IV: MINIMUM REQUIREMENTS FOR QUALIFICATION will be scored as described below.

A. SCORED QUESTIONS FOR THE DB ENTITY

An answer of "No" to any of Questions 1 – 8 will disqualify the Respondent's Qualifications Package.

An answer of "Yes" to any of Questions 9 – 15 will disqualify the Respondent's Qualifications Package.

B. SCORED QUESTIONS FOR THE PRINCIPAL ENGINEERING FIRM

The maximum possible score is 80. A minimum score of 60 must be attained or the Principal Engineering Firm will be disqualified, which in turn will disqualify the Respondent's Qualifications Package.

Note: Failure to provide an explanation for a "yes" answer to Questions B.4, B.5, and B.6 may result in immediate DB Entity disqualification.

Only those DB Entities that pass the minimum requirements described for PARTs I, II, III, and IV in the Statement of Qualifications (SOQ) will be further evaluated based on the full Respondent's Qualifications Package, including all PARTs I through VII of the SOQ. The DB Entity will be evaluated within the context and weighting of the following categories:

• DB Entity and DB Team Experience: 40 pts

• Key Personnel Experience: 40 pts

• Financial Capability: 20 pts

Respondent's Qualifications Packages will be ranked. The top ten scoring Qualifications Packages will be added to the Qualified Bidders List.

Scores from this RFQ process may be applied to proposal scores during the upcoming RFP evaluation process. The RFP will provide additional details.
