Enhancement Account Program (PTMISEA)

Staff was notified by CalTRANS that there are PTMISEA funds available to the region for capital projects. Redwood Transit has three buses that will pass their useful life of 500,000 miles by the end of the fiscal year. We would like to submit an allocation request to CalTRANS in the amount of \$526,680 to replace one of those buses.

The (PTMISEA) program was created by Proposition 1B, the Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006. Of the \$19.925 billion available to Transportation, \$3.6 billion dollars was allocated to PTMISEA to be available to transit operators over a ten-year period. PTMISEA funds may be used for transit rehabilitation, safety or modernization improvements, capital service enhancements or expansions, new capital projects, bus rapid transit improvements, or rolling stock (buses and rail cars) procurement, rehabilitation or replacement.

Funds in this account are appropriated annually by the Legislature to the State Controllers Office (SCO) for allocation in accordance with Public Utilities Code (PUC) formula distributions: 50% allocated to Local Operators based on fare-box revenue, and 50% to Regional Entities based on population.

There are \$476,169 in PUC Section 99313 funds available to the region through the Humboldt County Association of Governments, and \$50,511 in PUC Section 99314 funds to HTA.

<u>Action Recommended</u>: Adopt Resolution 15-01 Authorizing Application for Public Transportation Modernization, Improvement, and Service Enhancement Account Program Grant Funds and the General Manager to Execute all required documents.

RESOLUTION # 15-01 AUTHORIZATION FOR THE EXECUTION OF THE CERTIFICATIONS AND ASSURANCES

FOR THE PUBLIC TRANSPORTATION MODERNIZATION, IMPROVEMENT, AND SERVICE ENHANCEMENT ACCOUNT BOND PROGRAM

WHEREAS, the Humboldt Transit Authority is an eligible project sponsor and may receive state funding from the Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) now or sometime in the future for transit projects; and

WHEREAS, the statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 88 (2007) named the Department of Transportation (Department) as the administrative agency for the PTMISEA; and

WHEREAS, the Department has developed guidelines for the purpose of administering and distributing PTMISEA funds to eligible project sponsors (local agencies); and

WHEREAS, the Humboldt Transit Authority wishes to delegate authorization to execute these documents and any amendments thereto to the General Manager

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of Directors of the Humboldt Transit Authority that the fund recipient agrees to comply with all conditions and requirements set forth in the Certification and Assurances document and applicable statutes, regulations and guidelines for all PTMISEA funded transit projects.

NOW THEREFORE, BE IT FURTHER RESOLVED THAT:

- 1. HTA Governing Board authorizes the HTA General Manager, Greg Pratt, to submit an Allocation request to CalTRANS for \$50,511 of PUC Section 99314 funds to purchase a 40 foot, wheelchair equipped, 38 passenger bus for a total project cost of \$526,680, of which \$476,169 is to be paid from PUC Section 99313 funds.
- 2. The General Manager be authorized to execute all required documents of the PTMISEA program and any amendments thereto with the California Department of Transportation.
