#### DISCUSSION AGENDA

Amendment to Agreement for Operation of Bus Transit System in the Southern Humboldt Area.

The county requested that certain changes be made to the Agreement for the Operation of the Southern Humboldt Transit Systems. The amendments pertained primarily to insurance coverage and reporting requirements. The board reviewed the requested changes in detail.

### **Bus Shelter Improvement Project**

Humboldt Transit Authority received eight (8) bids from various construction firms to do the work for the bus shelter improvement project. Staff met with SHN and a representative from most of the bidders on February 19, 2010 to open the bids. After analyzing the bids and making adjustments for equality of review, the lowest bidder (\$493,265.92) for this project was Pierson Company. Staff recommended that the bid be awarded to the Pierson Company.
