There is a total of \$846,365 available to transit operators in Humboldt County for both small capital projects and some operating subsidies. The projects listed below were approved at the May17, 2012 Humboldt County Association of Governments Meeting.

WHEREAS, the RTPA, in accordance with Section 6754, Article 5, Subchapter 2.5, Chapter 3, Title 21, California Administrative Code, finds the following:

- a. (1) The claimants' proposed expenditures are in conformance with the adopted 2008 Regional Transportation Plan for Humboldt County June 2008.
- a. (2) The level of fares and charges on existing systems, and any initiated systems, is and will be sufficient to meet the fare revenue requirements of Public Utility Code Sections 99268.2, 99268.3, 99268.4, 99268.5 and 99268.9, as they may be applicable to the claimants.
- a. (3) The claimants are making full use of Federal funds available under the Urban Mass Transportation Act of 1964 (sic) (TEA-21), as amended.
- a. (4) The sum of the claimants' allocations from the state transit assistance fund and from the local transportation fund does not exceed the amount the claimant is eligible to receive during the fiscal year.
- a. (5) Priority consideration has been given to claims to offset reductions in federal operating assistance and the unanticipated increase in the cost of fuel, to enhance existing public transportation services, and to meet high priority regional or public transportation needs.
- b. (1) The operators, pursuant to Public Utilities Code Section 99244 have made a reasonable effort to implement productivity recommendations, including accounting reconciliation and operational improvements.
- b. (2) The operators, in relationship to claimants, is not precluded from the hiring of part-time drivers or entering contracts with any common carriers.
- b. (3) The claimants have received certification as appropriate from the California Highway Patrol verifying compliance with Section 1808.1 of the Vehicle Code.
- b. (4) The operators are in compliance with the eligibility requirements of Public Utilities Code Section 99314.6 or 99314.7.
- c. Not applicable.

WHEREAS, the RTPA deems the claimants to be in conformance with all applicable rules and regulations of the Public Utilities Code, Division 10, Part II, Chapter 4, Transportation Development, and Title 21, Chapter 3 of the California Administrative Code; and

WHEREAS, the RTPA specifies that payment of the allocation to the claimants be made as monies become available, with any reductions proportionate to reductions made by the State of California in the State Transit Assistance Fund.

NOW, THEREFORE, BE IT RESOLVED, that the Humboldt County Association of Governments allocates to the claimants a total sum of eight hundred forty six thousand, three hundred sixty-five dollars (\$846,365)

Dear Greg,

On behalf of myself and the HCAOG staff, I would like to begin this letter with a note of appreciation for you and your staff. We have undergone a number of changes in the past couple of years and appreciate your patience and partnership on a number of transit projects. It is a pleasure working with everyone at HTA. In particular, your readiness to join the Social Service Transportation Advisory Committee has been key in improving coordination and cooperation with transit users in the region.

The California Transportation Development Act (TDA) provides funding annually for public transportation. HCAOG, as the Regional Transportation Planning Agency (RTPA) for Humboldt County, administers the TDA funds. In August of 2011, HCAOG adopted, by resolution, findings regarding the existence of "unmet transit needs" and determinations on whether or not identified needs are "reasonable to meet". As transit is the priority use of these funds, the unmet transit needs determination must be met before allocating TDA funds for non-transit (i.e., streets and roads or non-regional bike and ped) purposes. The HCAOG Board made the finding that a fixed-route service on Saturdays to Willow Creek and Sunday service on the Redwood Transit Service main line (Trinidad to Scotia) were reasonable to meet.

Of these two needs, Saturday service to Willow Creek is currently fundable based on the history of the County's share of TDA funds used on non-transit projects. In previous discussions, July 1, 2012 was provided as a tentative start date for this service. I am requesting a confirmation of this date. If this service cannot be provided in the next fiscal year, only the amount required to fund the service will be held in the County Auditor Controller office until such a time that the service can begin. This month, HCAOG will be considering the allocation of regional transit funds to enable the implementation of Sunday service on the Redwood Transit Service main line.

Thank you again for your assistance and leadership in our transit system. Please do not hesitate to call me with any questions. I am also available to attend your Board meeting if necessary.
