This is a competitive grant for all rural agencies in the State of California. Staff is requesting approval from the HTA board to apply for \$300,000 in Operating Assistance to help offset the costs for the Intercity Systems in Willow Creek and Southern Humboldt. HTA has been successful in applying to this grant program for the past 13 years and the Local Transportation Funds can and will be used as the local match if awarded.

SUBJECT: 5311 Regional Apportionment Grant Funds

Each fiscal year, Regionally Apportioned Federal funds become available to the region. Staff has not been notified by the Humboldt County Association of Governments (HCAOG) that there is \$846,187 available in this year's Regional Apportionment Grant Fund program. CalTrans set the deadline for all agencies to submit their projects into the Online Electronic Grants Management System (Blackcat) by April 30, 2021. Although the deadline has passed, Staff has submitted the application and is being held pending board authorization.

For both Eureka Transit and Redwood Transit, Staff is requesting \$341,187 for Operating Assistance and \$495,000 for a Redwood Transit bus. HTA has been successful in applying to this grant program for the past 13 years and the Local Transportation Funds can and will be used as the local match if awarded.

SUBJECT: Coronavirus Relief and Response Supplemental Appropriations Act (CRRSAA) Call for Projects

On March 24, 2021 the Humboldt County Association of Governments (HCAOG) sent out a Call for Projects for CRRSAA funds for Federal Transit Administration (FTA) Section 5311 discretionary funds in the amount of \$2,237,106. Eligible projects are capital, planning and operating assistance.

The applications were due to Caltrans by April 30, 2021 and HTA Staff is requesting authorization from the HTA board to apply for Operating Assistance for the Eureka Transit Service and the Redwood Transit System. CRRSAA operating grant funds can be used through the end of fiscal year 2025. Although the deadline has passed, Staff has submitted the application and is being held pending board authorization.

All changes to the Classification Plan, Salary Schedule, and Job Descriptions require board authorization. A summary of the proposed change is as follows:

Classification Plan

Due to the pandemic, HTA has changed its cleaning and sanitizing procedures to make sure buses in-service are safe for the drivers and the public. In order to give more flexibility to the Maintenance Department to have buses fueled and keep up on daily cleanings, Staff is proposing adding another Vehicle Service Worker (VSW) to that department. Because duties of the Janitor position will be absorbed by the VSW and using the Cares Act grant to help fund the extra cleaning, there will not be any budget impacts.

The Humboldt Transit Authority is the Coordinated Transportation Services Agency for the region and is tasked with consolidating contracts, zones, and schedules to streamline the system to keep costs down and make it easier for the passenger to navigate the system.

Although Dial-A-Ride ridership has been low due to the pandemic, CAE Transport has been instrumental in assisting RTS, ETS, and AMRTS with providing transportation to passengers with disabilities. The last couple months DAR ridership has been steadily increasing as clients return to public transportation.

The proposed contract is for a one-year term beginning July 1, 2021 with no increase in cost for services.

SUBJECT: Eureka Transit Service; Proposed Saturday Route Changes

Due to low ridership and underutilized bus stops on Saturdays, Humboldt Transit Authority (HTA) is proposing consolidating its three existing Eureka Transit System routes into two (see Attachments B & C). Under the new plan, the Purple Route would be removed from the current schedule, and the existing Rainbow Route would be modified to maximize coverage.

Using passenger counters, HTA identified the least frequently utilized stops and determined which of the least utilized portions of the combined routes could be discontinued. In addition, HTA conducted a public outreach effort from March 1 through April 15, 2021. This included an online survey (see Attachment D), as well as an on-bus version of the survey, to capture both general community input and existing rider feedback.


The overall public response to the survey was minimal, with a total of seven responses received, and only one comment regarding the proposed changes to the draft plan. The responses resulted in requests for particular focus on the areas of West and 13th Street and West and 17th Street.

In conclusion, HTA recognizes that transit service is important to the community in general and especially to those who use it on a regular basis, with the majority of the survey respondents reporting using it frequently. With that in mind, we request you review and consider this information regarding the proposed route and schedule changes to the Eureka Transit Saturday Service. If approved the final plan (see Attachment E) will be announced to the general Public on June 1, 2021 and will take effect on July 1, 2021.





SUBJECT: Zero Emission Bus Fleet

The California Air Resources Board Innovative Clean Transit (ICT) Rule was adopted in December 2018 and requires all public transit agencies to gradually transition to a 100 percent zero-emission bus (ZEB) fleet. Beginning in 2026, 25% of new purchases must be ZEB's and in 2029, 100% of new purchases by transit agencies must be ZEBs, with a goal for full transition by 2040. It applies to all transit agencies that own, operate, or lease buses with a gross vehicle weight rating (GVWR) greater than 14,000 lbs. It includes standard, articulated, over-the-road, double-decker, and cutaway buses. The regulation encourages them to provide innovative first and last-mile connectivity and improved mobility for transit riders.

Based off the *"Total Cost of Ownership Comparison between Fuel Cell and Battery Electric Transit Fleets for Humboldt County"* report provided by the Schatz Energy Research Center earlier this year, zero emission infrastructure and fleet replacement will cost approximately 35 million dollars. Over the last few months Staff has researched and identified potential grants that could provide much needed zero emissions infrastructure and convert almost half of the fleet to Zero Emission Vehicles. Below is a summary of projects to help HTA become compliant with the ICT Rule.

- Microgrid System (on-site solar carports with battery storage)
- 7 electric buses for ETS and increased electric vehicle charging infrastructure
- Retrofit Maintenance Bays, to accommodate increased ZEBs
- 15 hydrogen fuel cell buses for RTS
- Hydrogen Fueling Station

Currently known funding possibilities include the federal "Rebuilding American Infrastructure with Sustainability and Equity" (RAISE) grant and the California State Transportation Agency (CalSTA) Transit and Intercity Rail Capital Program" (TIRCP). The RAISE grant application is due in July of 2021, with a 0 -20% local match requirement depending on the Humboldt County poverty rate. The TIRCP grant application will be due in October and has no local match requirement. Grant budgets have not yet been fully developed. However, we preliminarily anticipate seeking up to \$20 million in RAISE grant funding and/or TIRCP funding depending on timing and success of our grant submission.

HTA's eligibility for the RAISE and TIRCP grant, as well as other potential funding opportunities, would be greatly enhanced by improving transit in and out of Humboldt County through construction of an intermodal transit station. We have begun very early conversations with potential project partners and will update the Board as this project develops.

Staff will provide regular updates as the grant cycles proceed and grant budgets are developed.

ACTION RECOMMENDED: Discuss and give direction about proposed projects. Authorize the General Manager to apply for grants that will provide funding for the proposed projects, including the RAISE and TIRCP grants.



Eureka Scattered Site Project

Project Summary

Linc Housing is developing a three-site scattered site project in Eureka, CA. The project sites are located at Sunny & Myrtle Avenues (32 apartments), 6th & M Streets (35 apartments), 8th & G Streets (40 apartments). Due to the proximity of all three project sites, Linc Housing can apply as one scattered site "project". Each project site will include on-site automobile parking, short and long-term bicycle parking, an on-site live-in property manager (and on-site manager's offices), on-site resident services (and on-site resident services offices), a large community room, a courtyard with children's play equipment, and a laundry room.

Linc Housing and the City of Eureka will apply to the Affordable Housing and Sustainable Communities (AHSC) program on June 8, 2021. The AHSC program is funded by the State of California's Cap & Trade program. The total funding request will be between \$17.5 - \$20 million. The AHSC application scope not only includes financing for each of the project sites, but a grant that will fund public transportation, infrastructure, and public safety improvements which will benefit future residents of the affordable housing sites, but also surrounding businesses and neighbors. The AHSC application will be highly competitive because the project is applying in the Rural Innovation Project Area pool where the average density per project is 15 units per acre (the Eureka Scattered Site Project is 101.9 units per acre). By October 28, 2021, the applicant team will know if the Eureka Scattered Site Project is awarded.

If awarded AHSC financing, Linc Housing will submit an application for 9% tax credits to the California Tax Credit Allocation Committee (CTCAC) in March 2022. Tax credits are the primary source of funding for affordable housing in California. Competitive applications for 9% tax credits include well-amenitized project sites like the Eureka Scattered Site Project. Additionally, the most competitive applications for 9% tax credits apply using funding awards as leverage (such as the AHSC program). The Eureka Scattered Site Project would be highly competitive because it will leverage millions of dollars and scores full points in the latest iteration of CTCAC scoring criteria. If awarded 9% tax credits, the project will have all financing secured and will be able to begin construction in late 2022. All sites will be completed by 2024.

HTA Board Request

Linc Housing has requested five years of annual transit passes for 104 affordable housing units. Three years of the transit passes will be paid for using AHSC funds. Linc Housing is prepared to purchase an additional two years of annual passes. Since five years of annual passes would be purchased, Linc Housing seeks a reduced rate for a bulk purchase of annual passes. The purchase of transit passes is conditional upon receiving AHSC funding.

AHSC Scope / HTA Collaboration

As part of the AHSC application, the transportation scope includes several items that would benefit HTA including a new bus route, 1-2 express bus routes, an electric bus purchase, and capital improvements around bus stops near the three project sites. The estimated costs of these transportation improvements exceed \$2.5 million. The transportation improvements are conditional upon receiving AHSC funding.




