### **COMMUNITY MEMBERS COMMUNICATION**

Joann McGarry gave the board an update about riding the Redwood Coast Express system from Eureka to Ukiah on its first day of service, January 16, 2024. She described her experience as wonderful and added that she was the only passenger. Additionally, Joann expressed concern regarding the end of the Ally pass this coming semester and shared that passengers navigating transit will be facing challenges moving in the community. Finally, Joann recommends that HTA seek alternative methods to provide equitable fares and requested a new location for the Transit Center in the City of Arcata.

### **SPECIAL PRESENTATIONS**

Netra Khatri with the City of Arcata presented an outline for the project on Reconnecting Arcata and stated that partnership with HTA over the next 3-5 years is important.

The Reconnecting Arcata project seeks to address mobility, accessibility, and equity challenges in this rural area caused by three state highways (U.S. Highway 101 and state Routes 255 and 299) through a comprehensive, community-driven planning process. Key solutions include a new transit center, potential freeway cap or new crossings, and expanded walking and biking options. The state highway system created barriers to Arcata neighborhoods and nearby communities. Bridging this gap will help improve public health while providing more alternative transportation options.

Councilmember Leslie Castellano mentioned that the project was in the design phase. Councilmember Alex Stillman expressed the need for HTA Staff to be involved during the project phases. Supervisor Mike Wilson expressed his support for the project and a new transit hub in the future. Chairperson Natalie Arroyo, Councilmembers Steve Ladwig, Leslie Castellano, and Debra Garnes were all in favor of placing this as an agenda item for future meetings.

### TIRCP Cycle 5 Grant

This project funds the purchase of fuel cell electric city buses, construction of a hydrogen fueling station, upgrades to maintenance bays, and construction of an intermodal transit center.

### Redwood Coast Express (RCX)

a. Marketing consultant is visiting this week taking photo and video footage to be used for RCX as well as our RideHumboldt rebranding effort.

# TIRCP Cycle 6 Grant

This project will fund the development and testing of a fuel cell electric over-the-road coach.

- HTA staff sent our funding allocation plan and formal request for funding in February. We are waiting to hear back from CalSTA staff on next steps.
- CalTrans grant management staff are following up with CalSTA to inquire about the status of this.

### Microtransit

This topic captures various microtransit-related projects.

### **BACKGROUND and RATIONAL**

An intermodal transit center has been envisioned for development in the City of Eureka for many years. The concept is listed in the Regional Transportation Plan (RTP) as a proposed Regional Project for Public Transportation, codified in the City of Eureka General Plan, Policy M-4.3, and included in HTA's Capital Plan in the 2023-2028 Transit Development Plan.

In July 2022, HTA was awarded a \$38.7 million grant from California State Transportation Agency Transit and Intercity Rail Capital Program ("TIRCP Grant") for several transit related projects, including \$10 million allocated for construction of an intermodal transit center ("ITC") that integrates local and intercity bus service with carshare, rideshare, bicycle and pedestrian travel to provide infrastructure and services supporting multiple modes of transportation; enhancing customer convenience; and increasing commuter, shopper, visitor and residential ridership. This award is contingent upon collaboration with an affordable housing developer to integrate affordable housing with the ITC to create a true mixed use transit-oriented development. The ITC combined with the affordable housing represents the full project (Project).

On October 5, 2022 the Board authorized the GM to execute a Master Agreement and Program Supplements with the California Department of Transportation (CalTrans) to implement the TIRCP Grant. HTA entered into Master Agreement No. 64HTAMA and Program Supplement No. 02HTAPS on November 7, 2022. HTA staff submitted a funding allocation plan to CalTrans which was approved by the California Transportation Commission (CTC) during the December 7<sup>th</sup>, 2022 CTC meeting.

HTA has withheld an allocation request for the grant funding allocated for the ITC until a developer is procured by the City of Eureka. This is to allow collaboration with the developer to ensure appropriate funding amounts are applied to the appropriate project phase(s), and to avoid starting a count down clock imposed on allocated funding regarding contracting and phase execution time limits. Delaying the request for allocation does not risk losing TIRCP grant funds earmarked for the ITC.

Over the last year HTA staff has been collaborating with the City of Eureka as they worked to procure a developer for this Project. The City of Eureka has identified Danco Communities, a California Corporation ("Danco") as the developer of this project.

# A RESOLUTION OF THE HUMBOLDT TRANSIT AUTHORITY GOVERNING BOARD OF DIRECTORS APPROVING TIRCP GRANT COMMITMENT OF UP TO \$10 MILLION TO DANCO COMMUNITIES LLC AS A SOLE SOURCE CONTRACTOR FOR DEVELOPMENT OF THE EUREKA INTERMODAL TRANSIT CENTER

# **Recitals**

WHEREAS, in July 2022, HTA was awarded a \$38.7 million grant from California State Transportation Agency Transit and Intercity Rail Capital Program ("TIRCP Grant") for several transit related projects, including \$10 million allocated for construction of an intermodal transit center ("ITC") that integrates local and intercity bus service with carshare, rideshare, bicycle and pedestrian travel to provide infrastructure and services supporting multiple modes of transportation; enhancing customer convenience; and increasing commuter, shopper, visitor and residential ridership.

**WHEREAS**, on October 5, 2022 the HTA Board of Directors adopted Resolution No. 22-21, approving a Master Services Agreement with the California Department of Transportation to implement the TIRCP Grant;

**WHEREAS**, the location for constructing the ITC is one which is centrally located, readily serviced by HTA's different transit systems as well as Redwood Coast Transit, Amtrak and Greyhound in order to allow for convenient use and transfers, and is currently available for development;

WHEREAS, HTA and the City of Eureka have identified the ideal location for the ITC to be on City-owned property located on 3rd Street between G and H Streets, identified by APNs 001-136-001-000 and 001-136-002-000 ("Property"), because it is located in a central area of the City's downtown near the main Highway 101 travel routes, and at or near where Amtrak, Greyhound, Redwood Coast Transit, ETS, RCX, RTS, SHI, and Flex currently have bus stops;

**WHEREAS**, HTA has not identified any other parcels that are centrally located, readily serviced by HTA's different transit systems as well as Redwood Coast Transit, Amtrak and Greyhound, and currently available for development of the ITC;

**WHEREAS**, the City of Eureka also seeks to develop the Property for affordable housing consistent with its 2019-2027 Housing Element Implementation Program IMP H-34 (Affordable Housing on City-Owned Properties);

WHEREAS, in November 2021, HTA and the City of Eureka entered into a Memorandum of Understanding concerning the development, construction and operation of the ITC on the Property in such a manner that would be consistent with and supportive of its housing

development goals;

WHEREAS, HTA and the City of Eureka envision the combined ITC housing project to consist of a single integrated multi-story building with the ITC on the ground floor and housing located on floors above the ITC; the ITC would be owned and operated by HTA and the housing would be owned and managed by a qualified affordable housing entity;

WHEREAS, pursuant to its rules and procedures, the City of Eureka selected Danco Communities, a California Corporation ("Danco") to own, develop, and manage deed-restricted affordable housing on the Property, and anticipates entering into a Disposition and Development Agreement with Danco through which Eureka will transfer Property ownership to Danco in exchange for Danco's commitment to construct and manage affordable housing on the Property;

**WHEREAS**, Danco has successfully constructed and now owns and manages numerous affordable housing and mixed-use projects throughout Humboldt County and California;

WHEREAS, HTA's Procurement Policy requires open and competitive procurement pathways in order to obtain cost effective pricing, but recognizes that sole source is appropriate when there is only one contractor able to perform a contract, such as development and construction of the integrated ITC and affordable housing structure on the Property by the City of Eureka's selected developer;

**WHEREAS**, as a further consideration, it would be physically impracticable, if not impossible, to construct the ITC on the Property using a contractor other than the contractor selected by the City of Eureka due to the structural integration of the ITC and housing components in the same building;

**NOW THEREFORE,** the Governing Board of the Humboldt Transit Authority hereby resolves as follows:

- 1. All Recitals and Attachments are incorporated into this Resolution.
- 2. The City of Eureka-owned Property located on 3rd Street between G and H Streets (APNs 001-136-001-000 and 001-136-002-000) is the ideal location on which to construct the ITC because it is centrally located, readily serviced by HTA's different transit systems as well as Redwood Coast Transit, Amtrak and Greyhound, and is currently available for development.
- 3. No other parcels currently exist on which the ITC should be constructed.
- 4. Developing the Property with a single multi-story building that by design and structure combines the ITC on the ground floor, with housing on the floor above the ITC necessitates HTA's use of the same affordable housing developer selected by the City of

Eureka.

- 5. The City of Eureka has selected through its applicable procurement process Danco to develop the Property for affordable housing.
- 6. Danco has the experience and qualifications to construct the combined ITC and affordable housing project.
- 7. The General Manager is authorized to execute a letter of funding commitment to Danco, committing up to \$10 million of the TIRCP Grant to construct the ITC on the Property.
